OIL SPILL



CONTEXT

- As per Indian Coast Guard, Oil spill originating from Chennai Petroleum Corporation Ltd refinery has spread across 20 square kilometres into the sea.
- It has been over 10 days since the spill was reported, and its impact has affected hundreds of families whose livelihoods depend on the coastal habitat, biodiversity and aquatic life.



ABOUT

- An oil spill is the release of a liquid petroleum hydrocarbon into the environment, especially the marine ecosystem, due to human activity, and is a form of pollution.
- ➤Oil spills can occur in various ways, such as releases of crude oil from tankers, offshore platforms, drilling rigs, and wells.

CAUSE OF OIL SPILL IN CHENNAI

The oil spill in Chennai in December 2023 was caused by inadequate stormwater management at the Chennai Petroleum Corporation Limited (CPCL) premises, which led to overflowing of oil mixed water amid last week's floods triggered by Cyclone Michaung.

IMPACTS OF OIL SPILL


- It can cause health problems like heart damage, immune system effects, headache due to strong odour, skin irritation etc.
- ➤Oil spills have significant environmental and economic impacts too.

 They can affect the level of dissolved oxygen in the water and harm many forms of aquatic life.

It can obstruct passage of sunlight into sea, thereby destroying photosynthesising phytoplankton.

REMEDIAL OPERATIONS

➢ Bioremediation is one of the most effective method in addressing the oil spill and has a positive impact on the environment, as concluded by National Institute of Ocean Technology (NIOT).



STEPS TAKEN FOR PREVENTING OIL SPILLS

≻India

National Oil Spill Disaster Contingency Plan by Indian Coast Guard.

Merchant Shipping Act, 1958 has provision of Prevention and Containment of Pollution of sea by oil.

➤ Global

International Convention for Safety of Life at Sea (SOLAS) and Prevention of Pollution of marine environment from Ships (MARPOL).

India is party to both conventions.

Multi-angle Imaging SpectroRadiometer (MISR) instrument on NASA's Terra spacecraft was used to measure changes in vegetation along the coastline to assess the impact of oil spills on swamps, bayous, and beaches.

E-CIGARETTES

14 December 2023 - Urgent action is needed to control e-cigarettes to protect children, as well as non-smokers and minimize health harms to the population. E-cigarettes as consumer products are not shown to be effective for quitting tobacco use at the population level. Instead, alarming evidence has emerged on adverse population health effects.

ABOUT

- E-cigarettes or electronic nicotine delivery systems (ENDS), are tobacco products that have been sold in the USA for about a decade.
- They are battery-operated devices that allow users to inhale an aerosol containing nicotine or other chemicals.

CONCERNING ISSUE

E-cigarettes are the most commonly used tobacco products among kids and studies consistently show that young people who use e-cigarettes are almost three times more likely to start smoking cigarettes.

IMPACTS OF E-CIGARETTES

- >E-cigarettes with nicotine are highly addictive.
- It can generate toxic substances that can cause cancer and increase the risk of heart and lung disorders.
- ➤ It can negatively affects fetal development and brain development.

RECOMMENDATIONS BY WHO

The WHO has recommended that countries take urgent measures to prevent the uptake of e-cigarettes and counter nicotine addiction, including banning all flavors, limiting the concentration and quality of nicotine, and taxing e-cigarettes.

LEGISLATIONS IN INDIA REGARDING E-CIGARETTES

- In India, e-cigarettes were banned in 2019 under the Prohibition of Electronic Cigarettes Act, which came into force in September 2019.
- The ban prohibits the production, manufacture, import, export, transport, sale, distribution, storage, and advertisement of e-cigarettes.

- Despite these penalties, e-cigarettes are reported to be widely available across various sources, including tobacconists, general stores, and online providers.
- There is currently no law addressing the use of e-cigarettes in indoor public places, workplaces, and public transport in India, so the use of e-cigarettes is allowed in these areas


SOUTHEAST ASIA OPIUM SURVEY 2023



Southeast Asia Opium Survey 2023
Cultivation, Production, and Implications

CONTEXT

The United Nations Office on Drugs and Crime (UNODC) released a report "Southeast Asia Opium Survey 2023: Cultivation, Production and Implications".



KEY FINDINGS

- Myanmar has become the top global producer of opium in 2023, overtaking Afghanistan.
- Afghanistan's opium production has sharply declined due to the Taliban's efforts to eliminate illegal drug cultivation.
- The rise in opium cultivation in Southeast Asia is linked to poverty, poor government services, economic hardships, and regional instability.

MYANMAR'S OPIUM PRODUCTION SURGE: CAUSES

- ➤ Its location in the Golden Triangle
- A lack of effective governance in border areas, where ethnic minority militias, some involved in the drug trade, operate with relative autonomy.
- Economic difficulties, including limited market access, poor state infrastructure, and high inflation, influencing farmers to cultivate more opium.


THE GOLDEN TRIANGLE

This region encompasses areas within Myanmar, Laos, and Thailand.



THE GOLDEN CRESCENT

- This area covers parts of Afghanistan, Iran, and Pakistan.
- It stands as a major global center for the cultivation and distribution of opium.



IMPACTS ON INDIA

- Crime Growth: Enhanced drug trade fuels organized crime and violence.
- Law Enforcement Stress: Rising opium production strains law enforcement resources.
- ➤ Health Risks: Increased heroin production leads to higher addiction and disease risks.

- Terrorist Funding: Drug profits may finance terrorism, threatening national security.
- ➤ Healthcare Strain: Rising drug abuse overwhelms treatment facilities, impacting care.

UNODC

- >The UNODC was established in 1997.
- ➤ Its purpose is to assist the UN in addressing issues related to:
 - Illicit drug trafficking and abuse
 - Crime prevention and criminal justice
 - International terrorism
 - Political corruption
- The headquarters of the UNODC is in Vienna, Austria.

INDIRA GANDHI PEACE PRIZE



CONTEXT

➤ Daniel Barenboim, a renowned classical pianist, and Ali Abu Awwad, a prominent peace activist has been jointly awarded the 2023 Indira Gandhi Prize for their efforts in fostering a non-violent resolution of the Israel-Palestine conflict.



IMPACT

- Their work emphasizes the role of dialogue, culture, and people's participation in resolving conflicts peacefully.
- They have been instrumental in bringing together youth from Israel, Palestine, and other Arab and North-African countries.
